General information

1. Exposition terms

The partitions for the poster show will be set up by a specialist booth construction company according to the plans provided by the organizer. As exhibits, graphical material made of paper or plastics mounted on a solid board by e.g. double-sided adhesive tape may be used. Heavy boards may be suspended from the upper partition frames by special hooks, provided the boards are equipped with at least two rings. Fixing material will be provided by the booth construction company.

The exhibitor is liable for any damages to the exhibits, rented stand systems or booths. Otherwise the General Terms and Conditions shall apply (see excerpt from the General Terms and Conditions of Participation). Every stand includes one chair.

It is also possible to use your own partitions.

2. Display of information material and small exhibits

The stand systems feature small cabinets with sliding doors for the display of small exhibits. Dimensional requirements and weight limits to be observed are listed under "Technical data and rates".

3. Booking procedure

Please make your booking with the enclosed registration form. The bookings are handled on a "first come, first serve basis". The exhibition space is limited. The exhibiting company will receive a written confirmation from the organizer.

Extract from the General Terms and Conditions of Participation

1. Conditions of application

Application for participation shall be submitted to Verlag Stahleisen GmbH on an application form to be filled in and executed by duly authorised signatories. By submitting said application form, Exhibitor fully acknowledges all the Terms & Conditions of participation therein set forth.

2. Exhibits

The conditions specified by the Organizer with regard to dimensions, weights and other technical data of the exhibits are binding on all Exhibitors and must be taken into account when the exhibits are set up. In case of contravention the Organizer is entitled to revoke permission to exhibit.

3. Stand renting

On acceptance of application and after division of the available area, Exhibitor will be allocated a specific stand. Organizer will state in the application form a minimum stand area. The assignment to a third party of any rights from the admission to participate, whether wholly or in part, shall require Organizer's prior written consent.

4. Rental and additional expenses

Value-added Tax shall be charged separately in all invoices at the rate then current in Germany.

5. Stand equipment and design

Organizer has laid down, and Exhibitor agrees to comply with, certain regulations covering stand design, stand dimensions, and stand construction. Any additional structures, furnishings and fittings will be charged to Exhibitor and are subject to approval by the exhibition stand contractor (Messebaufirma). Exhibitor is not allowed to drill holes or hammer nails into walls, ceilings or floors. Pictures may be mounted to the stand walls with adhesive tape. The exhibition stand contractor (Messebaufirma) can supply special hooks for suspending heavy displays.

6. Assembling/dismantling stands

The time allowed for assembling and dismantling stands as stated in the Exhibitor Information leaflet are binding on all exhibitors.

7. Cancellation

Companies having submitted applications which have been accepted in writing by Organizer cannot be released from the contract. Should nonetheless Organizer expressly and in writing agree to a cancellation of the lease, Exhibitor shall pay to Organizer liquidated damages equivalent to 50% of the stand rental, irrespective of any proof or loss incurred by Organizer.

8. Security

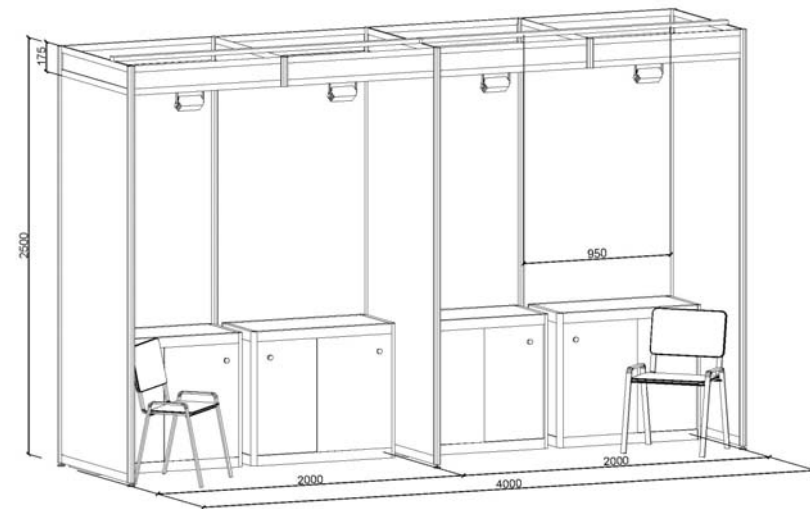
Organizer is solely obligated to ensure that during the opening hours of the event security attendants are posted at exhibition entrances and exits. Organizer will not provide stand guards. Organizer accepts no liability for theft, personal injury or damage to property

9. Exemption from liability/insurance

Organizer accepts no liability whatsoever for any such damage to or loss of Exhibitor's or rented property or for any such personal injury as may be caused by, and whether or not attributable to any such fault of, Exhibitor or his agents or servants during the assembly and dismantling of the stand or during (un)loading or transport. Any such liability is excluded even if Exhibitor or his assistants cannot be held responsible for the loss or damage incurred. Exhibitors are recommended to take out insurance to cover normal insurable risks and hazards from fire, theft, water, bad weather, damage e.t.a. in respect of exhibits, stand elements and stand equipment while on site and/or in transit.

Pillars: Aluminium system, colour silver

Lighting: 2 spots 150 W (incl. Power supply)
